networks. Now as technology brings more resources to our mobile devices and fingerprints, 'gig platforms' meet current and new needs, while creating millions of jobs in their workplaces.

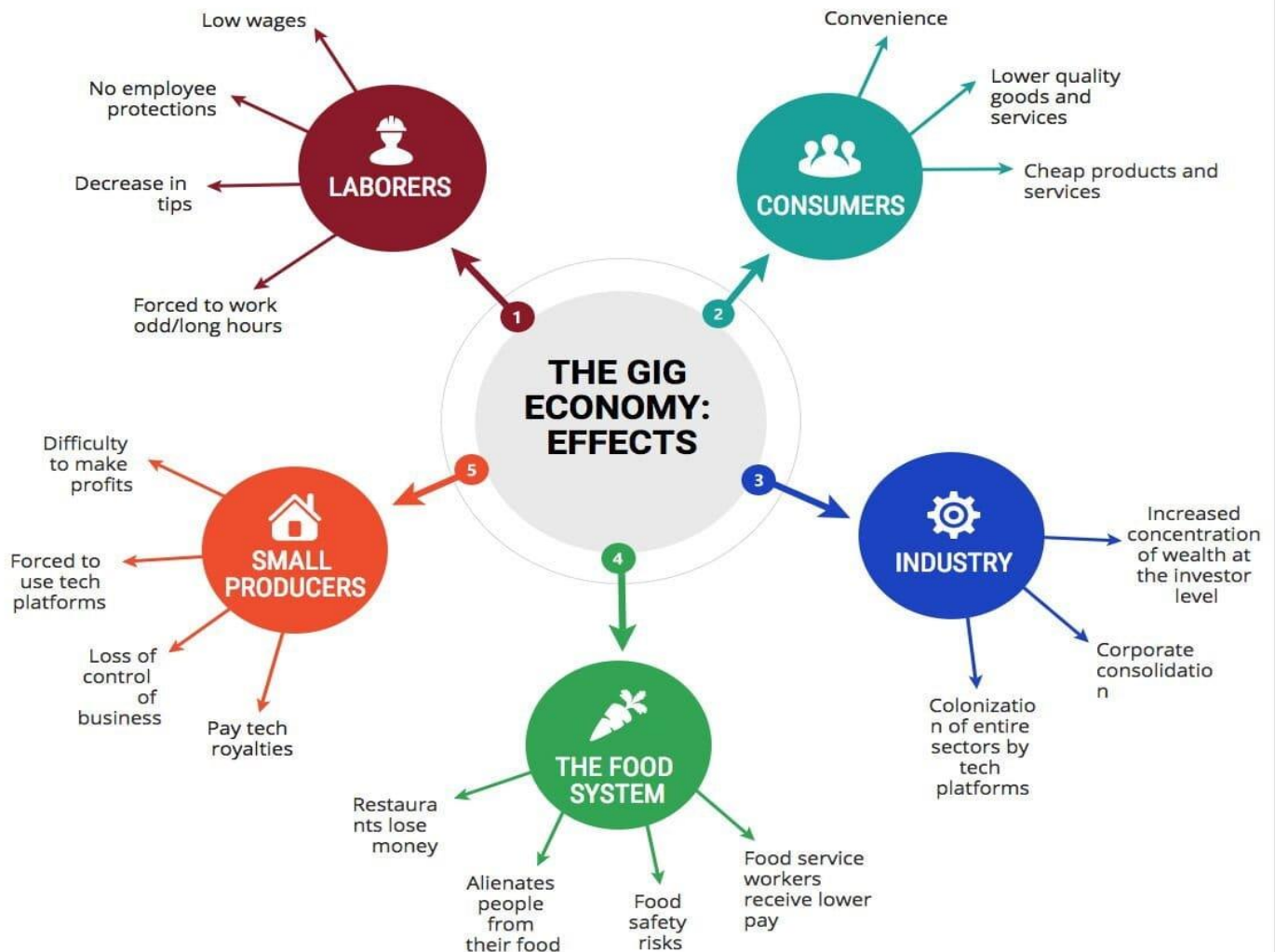
