CHAPTER ONE

INTRODUCTION

1.0 Background of study

Many people are travelling with airplanes, either as means of daily transportation to and from work or when going on vacation, to mention a few. To make reservations for such travels, airline companies' websites holds the functionality for the user to book a travel himself. A functionality which these websites lack is the option for the user to set up specific requirements for a travel, such as; minimal travel time or travel distance(Jarvenpaa L. S, 1996). The purpose of this project is to develop an easy-to-use airline reservation system, which accommodates these functionalities.

In addition, the system should also be of use for travel agencies. These should have the same functionalities in the system as the private users, but with the difference of also having a minimum spanning tree at their disposal, thus enabling them a greater understanding of the flight network.

Evolving from manual records and logs in the early 1930s, Airlines Reservations System (Arsanjani) is the improved, computerized feature of airline reservations(Winston, 1995). ARS helps in systematic and effective organization of bookings, prices, schedules and customer data. Airlines reservations system has today evolved into Computer Reservations System (CRS). ARS, when integrated with Global Distribution System (GDS), can be used by multiple distribution channels such as travel agencies, which can then use it for hotel rentals, flight booking, car hires as well as activities and tours via single system. ARS consists of several areas such as the inventory management, availability display and reservation and fare quotes and tickets. American Airlines introduced the first automated ARS called the Electromechanical Reservisor in 1946. It was followed by a new machine

called MagnetricReservisor. In 1959, to improve the existing Reservisor, an improved automated booking system called SABRE was introduced(Winston, 1995). Similarly, other airlines created their own systems for ticket booking and management. Today, many brands co-operate with the world airlines companies for user-friendly direct systems, increased productivity and efficiency. Some of the major ARS brands today are Abacus, Amadeus, Navitaire, Sabre and TravelSky.

1.1 Statement of the problem

The management of Airline in Nigeria for example has over the years attracted poor patronage as a result of errors inherent in the system. It is no longer a new thing that loss of customers' goods is now the order of the day; the reasons are not far-fetched. Due to this manual procedure involved in Airline management, clients have no other option than to be at the mercy of these error prone procedures. The method of information storage is poor. This limits the number of official documents accessible by the customers because the system is not capable of managing old items of reservations which could be of use to the customer at any time. There is little or no security control system where the customers' goods, document and classified information of the customer could be safe guarded from unauthorized access.

1.2 Purpose of the study

This project is aimed at exposing the relevance and importance of Airline reservation system (ARS). It is projected towards enhancing the relationship between customers and airline agencies through the use of ARSs, thereby easing the flight ticketing and selling process and all air travelling operations.

1.3 Aim and Objectives

The aim of the project is to design and implement the software which helps the Airline System employees to issue reservation tickets for various Air flights and maintain the records of various passengers and provide quick services to the passengers.

The objectives include:

1. To maintain consistency among different access modes, e.g. by phone, by web, at the information desk and across different physical locations.
2. To minimize repetitive work done by the system administrator and reservation clerks.
3. To maintain customer information in case of emergency..
4. To Increase awareness among frequent travelers about various special offers and discounts.
5. To minimize the number of vacant seats on a flight and maximize flight capacity utilization.
6. To maintain the capability to adopt a flexible pricing policy.

1.4 Significance of study

The significance of Airline reservation system is the computerization of the activities of the organization. It helps to facilitate the daily operation of the organization. The economy of the organization is affected positively because of the computerization of their operation.

The findings of this research will also help the management to increase the income generation and smooth running of the everyday activities. This presentation will be beneficial to all those who make use of Airline flight information system (ARSs), flight operators, air travelling operators, travel agents and airline agencies.

1.5 Methodology

CHAPTER TWO

LITERATURE REVIEW

2.0 Introduction

An airline reservation system is a part of so-called Passenger Services Systems (PSS), which are applications supporting the direct contract with the passenger(Crosby, 2015).

The airline reservation system was one of the earliest changes to improve efficiency. Airline reservation system eventually evolved into the Computer Reservation System(CRS). Computer reservation systems is used for the reservation of a particular airline and interface with a Global Distribution System (GDS) which travel agency and other distribution channels in making reservations for most major airlines in a single system

2.1 Review

The history of airline reservations systems began in the late 1950s when Airlines required a system that would allow real-time access to flight details in all of its offices, and the integration and automation of its booking and ticketing processes. As a result, Sabre(Semi-Automated Business Research Environment) was developed and launched in 1964(C. Winston, 1995). Sabre's breakthrough was its ability to keep inventory correct in real time, accessible to agents around the world. Prior to this, manual systems required centralized reservation centres, groups of people in a room with the physical cards that represented inventory, in this case, seats on airplanes.

The deregulation of the airline industry, in the Airline Deregulation Act, meant that airlines, which had previously operated under government-set fares ensuring airlines at least broke even, now needed to improve efficiency to compete in a free market(Shon, 2003). In this deregulated environment the ARS

and its descendants became vital to the travel industry. In the early days of American commercial, passengers were relatively few, and each airline's routes and fares were tightly regulated by the Civil Aeronautics Board. These were published in a volume entitled *The Official Airline Guide*, from which travel agents or consumers could construct an itinerary, then call or telex airline staff, which would mark the reservation on a card and file it. As demand for air travel increased and schedules grew more complex, this process became impractical. This system was used in the hospitality industry.

In 1946, Airlines installed the first automated booking system, the experimental electromechanical Reservation. A newer machine with temporary storage based on a magnetic drum, the Magnetronic Reservisor, soon followed (Smith, 2002). This system proved successful, and was soon being used by several airlines, as well as Sheraton Hotel and Goodyear for inventory control. It was seriously hampered by the need for local human operators to do the actual lookups; ticketing agents would have to call a booking office, whose operators would direct a small team operating the Reservisor and then read the results over the telephone. There was no way for agents to directly query the system.

In 1953, Trans-Canada Airlines (TCA) started investigating a computer-based system with remote terminals, testing one design on the University of Toronto's Manchester Mark I machine that summer. Though successful, the researchers found that input and output was a major problem. Canada became involved in the project and suggested a new system using cards and a transistorized computer in place of the unreliable tube-based Mark I. The resulting system, Reser Vec, started operation in 1962, and took over all booking operations in January 1963 (Shon, 2003). Terminals were placed in all of TCA's ticketing offices, allowing all queries and bookings to complete in about one second with no remote operators needed.

In 1953, American Airlines CEO Smith chanced to sit next to R. Blair Smith, a senior IBM sales representative, on a flight from Los Angeles to New York. C.R. invited Blair to visit their Reservisor system and look for ways that IBM could improve the system. Blair alerted Thomas Watson Jr. that American was interested in a major collaboration, and a series of low-level studies started. Their idea of an automated Airline Reservation System (Arjanjani) resulted in a 1959 venture known as the Semi-Automatic Business Research Environment (SABRE), launched the following year (Johanson, 2014). By the time the network was completed in December 1964, it was the largest civil data processing system in the world.

Other airlines soon established their own systems. Delta Air Lines launched the Delta Automated Travel Account System (DATAS) in 1968. Airline sand Airlines followed in 1971 with the Apollo(Winston, 1995).

Reservation System and Programmed Airline Reservation System(PARS), respectively. Soon, travel agents began pushing for a system that could automate their side of the process by accessing the various ARS es directly to make reservations. Fearful this would place too much power in the hands of agents, American Airlines executive Crandall proposed creating an industry-wide Computer Reservation System to be a central clearinghouse for U.S. travel; other airlines demurred, citing fear of antitrust prosecution(Rudstrom, 2004).

An Airline Reservation System is part of the so-called Service Systems(PSS), which are applications supporting the direct contact with the passenger.

The Airline Reservations System (Arsanjani) was one of the earliest changes to improve efficiency. ARS eventually evolved into the Computer Reservations System(CRS). A Computer Reservation System is used for the reservations of a particular airline and interfaces with a Global Distribution System(GDS) which supports travel agencies and other distribution channels in making reservations for most major airlines in a single system(Rudstrom, 2004).

Airline Reservations Systems contain airline schedules, fare tariffs, passenger reservations and ticket records. An airline's direct distribution works within their own reservation system, as well as pushing out information to the GDS. A second type of direct distribution channel is consumers who use the internet or mobile applications to make their own reservations. Travel agencies and other indirect distribution channels access the same GDS as those accessed by the airlines' reservation systems, and all messaging is transmitted by a standardized messaging system that functions primarily on TTY messaging called SITA(Erradi, 2006). Since airline flight information system are business critical applications, and their functionally quite complex, the operation of an in-house airline reservation system is relatively expensive.

Prior to deregulation, airlines owned their own reservation systems with travel agents subscribing to them. Today, the GDS are run by independent companies with airlines and travel agencies as major subscribers.

As of February 2009, there are only three major GDS providers in the market space: Amadeus, Travel port(the merged span and Galileo systems), Sabre and Shares. There is one major Regional GDS,

Abacus, serving the Asian marketplace and a number of regional players serving single countries, including Travel sky (China), Infini and Axes (both Japan) and Topaz (South Korea). There is a secondary GDS called Navitaire that hosts "ticket less" airlines such as AirTran, and previously JetBlue(Atkinson, 2015). Virgin America is hosted by iflyRes(AIRes), which is a new generation reservation system developed and operated by IBS Software Service Pvt. Ltd.

In addition to these "standardized" GDS, some airlines have proprietary versions which they use to run their flight operations. A few examples of this kind of system are Deltamatic (built off the Worldspan platform) and EDS SHARES. SITA Reservations remains the largest neutral multi-host airline reservations system, with over 100 airlines currently managing inventory.

An airline's inventory contains all flights with their available seats. The inventory of an airline is generally divided into service classes (e.g. First, Business or Economy class) and up to 26 booking classes, for which different prices and booking conditions apply(Bilotkack, 2011). Inventory data is imported and maintained through a Schedule Distribution System over standardized interfaces. One of the core functions of the inventory management is the inventory control. Inventory control steers how many seats are available in the different booking classes, by opening and closing individual booking classes for sale. In combination with the fares and booking conditions stored in the Fare Quote System the price for each sold seat is determined(Li X, 2004). In most cases inventory control has a real time interface to an airline's Yield management system to support a permanent optimization of the offered booking classes in response to changes in demand or pricing strategies of a competitor.

Users access an airline's inventory through an availability display. It contains all offered flights for a particular city-pair with their available seats in the different booking classes. This display contains flights, which are operated by the airline itself as well as code share flights which are operated in co-operation with another airline(Shao, 2008). If the city pair is not one on which the airline offers service it may display a connection using its' own flights or display the flights of other airlines. The availability of seats of other airlines is updated through standard industry interfaces. Depending on the type of co-operation it supports access to the last seat (Last Seat Availability) in real-time. Reservations for individual passengers or groups are stored in a so-called Passenger Name Record (PNR). Among other data, the PNR contains personal information such as name, contact information or special services requests (SSRs) e.g. for a vegetarian meal, as well as the flights (segments) and issued tickets. Some reservation systems also allow to store customer data in profiles to avoid data re-entry each time a new reservation is made for a known passenger(Arsanjani, 2004). In addition, most systems have interfaces

to CRM systems or customer loyalty applications (aka Frequent Traveller Systems). Before a flight departs the so-called Passenger Name List (PNL) is handed over to the System that is used to check-in passengers and baggage. Reservation data such as the number of booked passengers and special service requests is also transferred to Flight Operations Systems, Crew Management and Catering Systems. Once a flight has departed the reservation system is updated with a list of the checked-in passengers (e.g. passengers who had a reservation but did not check in (No Shows) and passengers who checked in, but didn't have a reservation (Go Shows)). Finally, data needed for revenue accounting and reporting is handed over to the administrative systems.

A computer reservations system (CRS) is a computerized system used to store and retrieve information and conduct transactions related to air travel (Johanson, 2014). Originally designed and operated by airlines, CRSes were later extended for the use of travel agencies. Major CRS operations that book and sell tickets for multiple airlines are known as global distribution systems (GDS). Airlines have divested most of their direct holdings to dedicated GDS companies, who make their systems accessible to consumers through Internet gateways. Modern GDSes typically allow users to book hotel rooms and cars as well as airline tickets (GazetteLive, 2011). They also provide access to railway reservations in some markets although these are not always integrated with the main system.

2.2 Working mechanism of flight booking

The users can easily purchase an e-ticket by going to the ticket sale website, searching and selecting the destination, entering the details such as name, way of travel, luggage information and dates and finally making the payment via bank cards, bank transfer or through online payment companies. The e-ticket is then emailed or texted on the telephone of the customer. While previously travel agents and airlines assisted customers in making ticket purchases, today with the improved internet system, it is getting easier and easier to book the flights on your own. After the customer makes the purchase, the electronic record and the details of the ticket are saved into airline's database. The database is integrated with the passenger service system, which is then connected to the airports, airlines, travel agencies for sharing real time information.

2.3 Advantages of airline reservation system

The reason why more and more people are purchasing their flight tickets online is because of the many advantages and conveniences online flight booking system has to offer. Opposed to the traditional way of purchasing tickets through travel agents' office, online reservation today provides the access to hundreds of flight paths, their prices and other services at the click of a button. This can be very important for the customer in order to find the best possible deal and the most convenient connection. Online system of booking flight tickets gives more control to the customers in terms of their holiday planning and helps them make informed decisions. The system of searching the flights is so easy, that anybody with a computer and internet access can easily search connections, compare prices and purchase any connection they wish to. Not only this, but this method is much faster, easier, hassle-free and convenient. Many flight companies these days also provide other services such as airport transfer, accommodation services, car hire and airport parking. The customers can also take advantages of frequent discounts, promotions and other offers from the airlines through subscribing to their email or simply by viewing their website. The clients can also fully be aware of the various policies of the company such as cancellation, baggage rules and others. and can easily make use of those services. Online flight booking not only provides easy and fast services to the customer from the convenience of computer from anywhere in the world, but often also provides services at more reasonable prices. Majority of airlines companies also provide the services of online check-in after which the customer can easily print the boarding pass at home and save considerable time and hassles at the airport.

2.4 Disadvantages of Airline reservation system

Online airline reservation system has its own set of limitations as well. Prospective clients in Asia and other parts of the world where the connection speed and availability is poor may find it hard to access the website of flight companies and book tickets. In much of the less developed part of the world, besides internet connectivity, the limited knowledge and access to technology can also hinder the chances of using this service. As a result, many people in the developing world still use the traditional method of purchasing tickets from the offices of travel agents. Machine failures such as lost connection or unresponsive program can sometimes also cause the disappearance of all the flight itinerary.

Furthermore, the customer might not be able to get correct or enough information from the website alone as it is not done face to face with a person who knows everything about the connections, offers and company policies. Then there is also the issue of security: it is sometimes possible that somebody can steal your credit card information but developers are improving the security of the system more and more with the advancement of technology.

CHAPTER THREE

Once the inputs are collected, the obtained data are processed properly for effective use. The data/information processed is stored in the computer for subsequent use.




Figure 3.3: Modules available for Costumers

3.3 Problems of Existing System

3.4 Justification for the new System

The outcome of this study will provide a basis for developing the appropriate approach to the problems associated with air traveling operations in relation to Airline flight information system (AFIS). The following objectives are to be achieved.

- Improve forecasting accuracy,
- Freeing up labor bottlenecks,

- Reducing the amount of product handling,
- Installing improvement targets,
- Enhancing efficiency in their operation

3.5 System Features

The Airline Reservation System has the following features:

This project is mainly intended for two types of audiences. One is the customer or the end user and the other is the administrator of the website. Some of the major functions of the system can be categorized under two different categories that are for the administrator and the user.

3.5.1 Customer / End user activities




Figure 3.2 - Customer use case diagram

Figure 3.2 is a use case diagram that depicts all the functions or activities that a user or a customer can perform on the application. They can be discussed in detail as follows:

Home Page: Like all the other airline websites available online, the user can access the user home page of the Airline Reservation System website, after he logs into the system. Here, he can look up information regarding flights schedules.

Login and Register: The Airline Reservation System also comes with the customer registration details page, where the customer can enter his details and register. He can also create a username and password. Moreover, he will also be able to modify the registration information in case of a change in his e-mail address or any other information.

Payment: The customer can pay for his/her flight ticket using this system by supply in his/her credit card details for transaction.

Cancel Flight: This is a functional module provided for user to cancel flight in case of any situation that may occur.

Update Flight: This functionality is helps the user to modify their flight reservation by changing their departing date date/time or/and arrival date/time.

Booking Instructions: The website also provides instructions to the customers on how to book airline tickets or motels along with the different packages.

Some of the functions of the Airline Reservation System, such as creating, maintaining and updating the database are available only to the administrator. The functions of the administrator, explained in detail are as follows:

3.5.2 Administrator Activities




Figure 3.3 - Administrator use case diagram

Login/Logout: The administrator has to login first in order to be able to make changes to the Airline Reservation System, by adding, deleting or modifying the data in the Airline Reservation System database. After making the necessary changes, he then has to logout of the system, in order to prevent misuse of the data.

Add/Modify Customer Information: Daily, the Airline Reservation System will have many customers registering with the website and many of them unsubscribing. Only the administrator will have the sole rights to modify the database accordingly.

Add/Modify Flight Information: The Administrator also has the sole rights to add, delete or modify the flight information. Sometimes, flights get cancelled for some reason, so such flights would be removed from the list of flights available to the customer. Similarly, whenever any flight information has to be modified or if any new flights need to be added to the database, these operations are performed by the administrator.

Cancellation of Reservations: Sometimes, after making a reservation, a customer might cancel the reservation he has made. So, the administrator also handles such special situations and sends the customer an e-mail confirmation after deleting the specific transaction.

E-mail confirmations: Whenever a customer makes or cancels a reservation, the administrator is responsible for sending confirmation e-mails to the customer, confirming the transaction.

3.6 Functional Requirements

The functional requirements of the Airline Reservation System are divided among the customer and the administrator of the application.

These functional requirements can be explained in detail as follows:

3.6.1 Use Case name: User Registration

- **Description:** This use case describes the scenario where the user registers with the application by providing all the necessary details, in order to make reservations or bookings for flights, motels, special packages.
- **Actor:** User or the Customer
- **Input:** The user or the customer will have to provide all the necessary details present in the customer registration form of the application.

- **Output:** All the details entered in the customer registration page will be verified and accepted by the system into the database.

3.6.2 Use Case name: User Login

- **Description:** This use case describes the scenario where the user logs into the application, with the username and password he has provided while registering with the system.
- **Actor:** User or the Customer
- **Input:** The user or the customer creates a username and password at the time of registering with the system. He then uses them to logon to the system and make reservations or view any information.
- **Output:** The application then verifies the authenticity of the username and password that the customer has provided and allows the user to view the information available on the system, if the username and password are valid.

3.6.3 Use Case name: Contact the company

- **Description:** This use case describes the scenario where the user contacts the company for any information.
- **Actor:** User or the Customer
- **Input:** The customer can contact the airline company, requesting them for any information he needs.
- **Output:** The application verifies the authenticity of the username and password that the customer has provided and allows the user to view the contact information for the company

3.6.4 Use Case name: Booking Instructions

- **Description:** This use case describes the scenario where the user views the instructions for booking flights, packages, or motels.
- **Actor:** User or the Customer
- **Input:** After the customer logs onto the application with his username and password, he can look up the instructions posted on the website for booking flights, packages or motels.

- **Output:** The application verifies the authenticity of the username and password and displays the how to book instructions page.

3.6.5 Use Case name: Book Flights

- **Description:** This use case describes the scenario where the user books airline tickets.
- **Actor:** User or the Customer
- **Input:** After logging into the application, the customer looks up the information related to various airlines and checks the availability of seats on flights. If he finds that there are any available tickets, he then purchases them.
- **Output:** The application verifies the authenticity of the username and password and then displays information related to various flights to the customer.

3.6.6 Use Case name: Cancel Flight

- **Description:** This use case describes the scenario where the user cancels a reserved flight for one case or the other.
- **Actor:** Customer or the user
- **Input:** After logging onto the application, the customer looks up the website navigation, click flight history. The system requires the user to select the reserved flight to be cancelled.
- **Output:** The system deletes the selected flight reservation of a particular user in the user-reservation database.

The administrator activities use cases will be described here:

3.6.7 Use Case name: Login/Logout

- **Description:** This use case describes the scenario where the administrator of the application, logs into the system and logs out after the work is done.
- **Actor:** Administrator
- **Input:** The administrator of the website logs into the application with the username and password provided to him.

- **Output:** The application verifies the authenticity and displays the home page of the administrator.

3.6.8 Use Case name: Add/Delete or Modify Customer information

- **Description:** This use case describes the scenario where the administrator adds, deletes or modifies customer information in the system database
- **Actor:** Administrator
- **Input:** The administrator of the applications logs onto the system with his username and password.
- **Output:** The application authenticates the administrator, and then displays the page where the administrator can add new customers to the database, or delete existing customers or modify details of customers in the database.

3.6.9 Use Case name: Add/Delete or Modify flight information

- **Description:** This use case describes the scenario where the administrator adds, deletes or modifies flight information in the application database
- **Actor:** Administrator
- **Input:** The administrator logs onto the system with the username and password provided to him.
- **Output:** The application authenticates the administrator, by verifying the username and password. Then the application displays the page where the administrator can add new flights to the database, delete the flights that have been cancelled or modify information for the flights.

3.6.10 Use Case name: Cancellation of Reservations


- **Description:** This use case describes the scenario where the administrator handles the cancellation of reservations by the customers.
- **Actor:** Administrator
- **Input:** The administrator logs onto the system with the given username and password.
- **Output:** The application authenticates the administrator and then displays the page where the administrator looks up the id of the customer who has requested cancellation of reservation.

After canceling the reservation, the administrator then sends a confirmation e-mail to the customer.

3.6.11 Use Case name: E-mail confirmations

- **Description:** This use case describes the scenario where the administrator sends e-mail confirmations to the customers of the application.
- **Actor:** Administrator
- **Input:** The administrator logs onto the application with the username and password provided.
- **Output:** The application then authenticates the administrator and displays the page where the administrator can send e-mail confirmations to the customer. These e-mail confirmations may be sent in cases where the customer has cancelled a reservation or changed the personal information available on the website.

3.7 Performance Requirements

The Airline Reservation System application should be able to respond to the queries submitted by the customer without much delay. When a user searches for a flight leaving from a particular place to another place, the application should not take much time to return the results, similarly for the motel and package information. Considering that the application is of moderate size, it should be able to display 10 results at a time on each page, when the customer looks up for any particular data. Since the Airline Reservation websites have much traffic, the user should also be able to logon to the system using high speed internet. Most of the requests sent to the application should be answered in less than 5 seconds.

3.8 Non-Functional System Requirements

Performance Requirements

Some Performance requirements identified is listed below:

- The database shall be able to accommodate a minimum of 10,000 records of customer data.
- The software shall support use of multiple users at a time.
- There are no other specific performance requirements that will affect development.

3.9 Safety Requirements

The database may get crashed at any certain time due to virus or operating system failure. Therefore, it is required to take the database backup.

3.10 Security Requirements

Some of the factors that are identified to protect the software from accidental or malicious access, use, modification, destruction, or disclosure are described below.

- Keep specific log or history data sets.
- Assign certain functions to different modules.
- Restrict communications between some areas of the program.
- Check data integrity for critical variables.

Communication needs to be restricted when the application is validating the user or license. (i.e., using https).

3.11 Software Quality Attributes

The Quality of the System is maintained in such a way so that it can be very user friendly to all the users.

The software quality attributes are assumed as under:

- Accurate and hence reliable.
- Secured.
- Fast speed.
- Compatibility.

3.12 System Interfaces

This section describes how the software interfaces with other software products or users for input or output.

3.13 User Interface

Application will be accessed through a Browser Interface. The interface would be viewed best using 1024 x 768 and 800 x 600 pixels' resolution setting. The software would be fully compatible with Microsoft Internet Explorer for version 6 and above. No user would be able to access any part of the application without logging on to the system.

3.14 Hardware Interfaces

- Operating System: Windows 7/xp or above, MAC or UNIX.
- Processor: Pentium 3.0 GHz or higher
- RAM: 256 Mb or more
- Hard Drive: 10 GB or more


3.15 User Characteristics

4.0 Introduction

The system was designed using Dreamweaver platform. This platform is enriched with many programming languages such as php, c++, c#, JavaScript and much more for windows programming. At the developing stage, after undergoing research and experiment on choices of programs and databases, PHP, JavaScript and MySQL were the major programming language and database used for developing the entire system.

4.1 System Design

The system is designed to have multiple windows form. This form tends to create the unique interaction between the user and the system to support them into achieving their flight reservation task. The form has been simplified to have various object representing certain identity that enable customers accomplish the reservation and to produce the output in due time.



The admin is different from customer's login form; this is done to avoid deadlock during transaction. The system requires that the admin feed in his/her username and password to interact with the system to authenticate the account.




Figure 4.6 Admin login page

4.4 Testing

Integration testing is a systematic testing for conducting tests to uncover errors associated within the interface. The objective is to take unit tested modules and build a program structure. All the modules are combined and tested as a whole. Here correction is difficult because the vast expenses of the entire program complicate the isolation of causes. Thus in the integration testing step, all the errors are corrected for the next testing steps. In Airline Reservation System each module is integrated and tested. This testing provides the assurance that the application is well integrated functional unit with smooth transition of data.

4.4.3 Validation Testing

At the culmination of integration testing, software is completely assembled as a package; interfacing errors have been recovered and corrected and a final series of a software tests-validation tests begin. Validation testing can be defined in many ways but a simple definition is that validation succeeds when the software functions in a manner that can be reasonably expected by the customer.

4.5 Implementation

Implementation is the stage in the project where the theoretical design is turned into a working system and is giving confidence on the new system for the users that it will work efficiently and effectively. It involves careful planning, investigation of the current system and its constraints on implementation, design of methods to achieve the changeover, an evaluation, of change over methods. The more complex system being implemented, the more involved will be the system analysis and the design effort required just for implementation.

An implementation co-ordination committee based on policies of individual organization has been appointed. The implementation process begins with preparing a plan for the implementation of the system.
