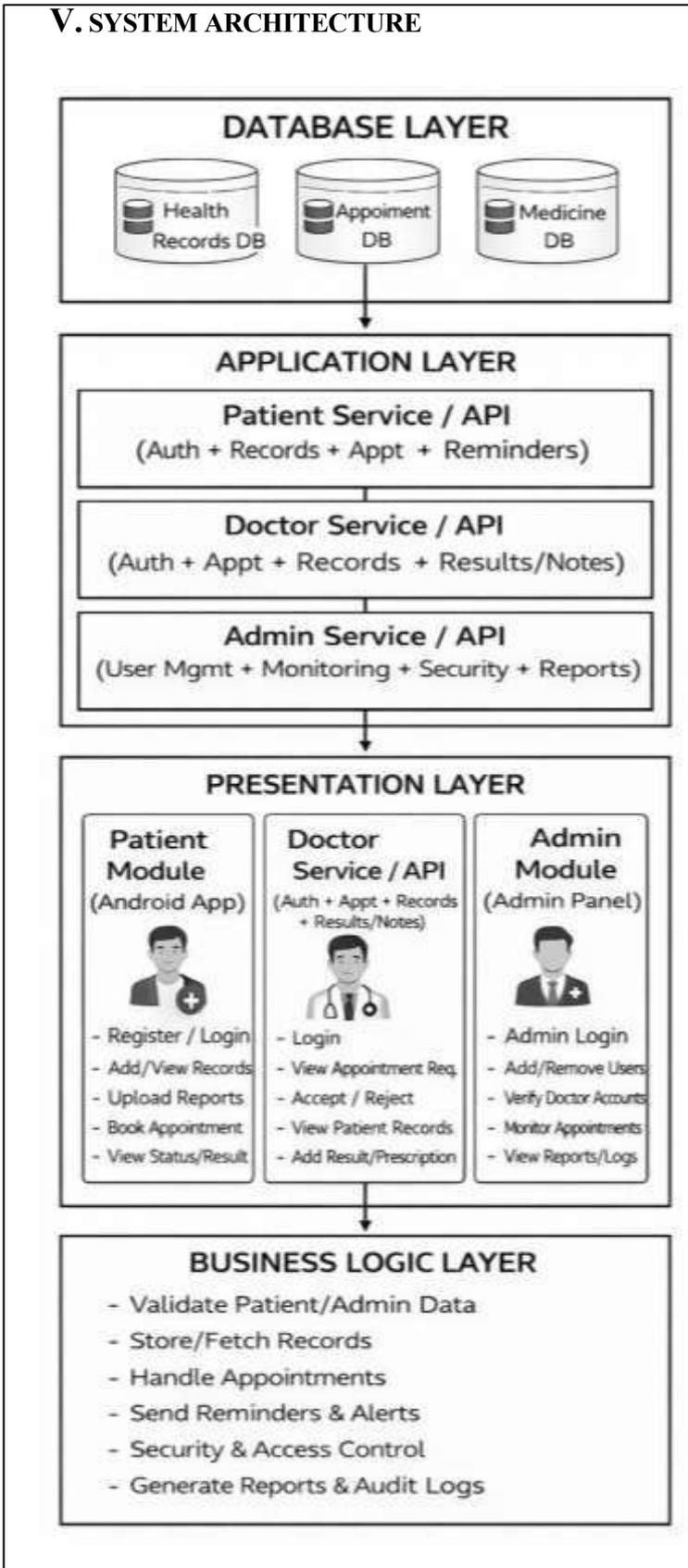


Figure 1- System

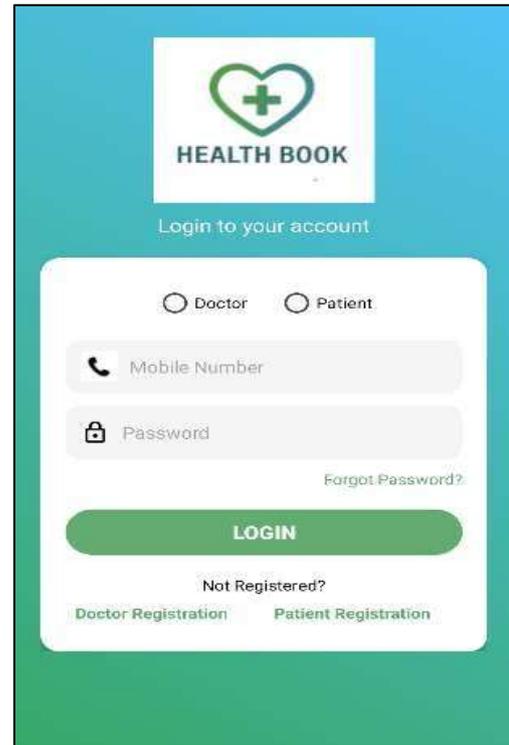


Figure 2- login page

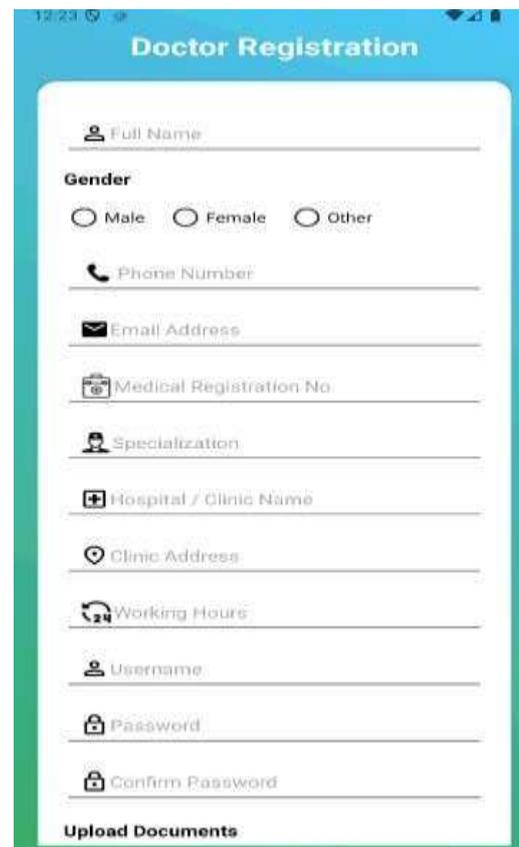


Figure 3- Doctor Registration

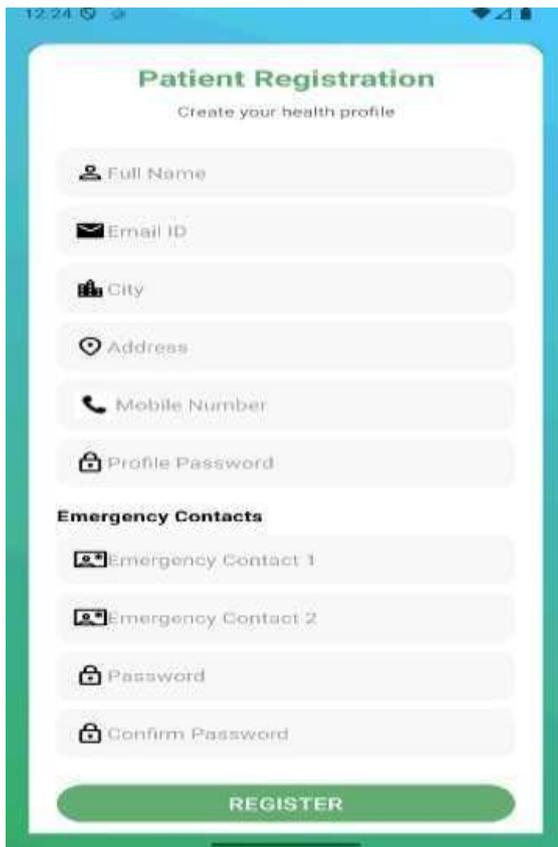


Figure 4- Patient Registration
