


Fig. 1. Docker and Container




Fig. 2. COMPONENTS OF EC2

1) INSTALLATION OF DOCKER

We expose port 8081:80 of the container to port 8081:80 of the host system. We also specify that this service depends on the db service, meaning that the db service will be started before the web service.

The db service uses the official MySQL 8.0 image from Docker Hub. We specify some environment variables to set the MySQL root password and database name.

- 6) RUNING THE IMAGE Here are the steps to build and run a single Docker image:
- The docker build command should be used to create the Docker image. You may name and tag the image with the -t option.

docker build -t my-php-app.

- Once the Docker image is built, you can run it using the docker run command. The -p option allows you to map a port on the host system to a port on the container. In this example, we are mapping port 8081 of the host system to port 80 of the container. docker run -p 8081:80 my-php-app.
- 7) UPLOADING DOCKER APPLICATION ON AMA- ZON WEB APPLICATION EC2 There are some steps involved:
- a) PHP Web Application (Without Any Errors)
- To begin, carefully analyze your code to look for typos and incorrect syntax. To assist you with this process, utilize a code editor or IDE that supports PHP.
- To guarantee that your online application func- tions and appears appropriately, test it across a variety of web browsers.
- To make sure everything operates as you would expect, test every feature of your web appli-cation. Forms, buttons, links, database connec-

tions, and any other features you've added go under this category.

- If any faults or problems occur when testing, use a debugging tool or piece of software to find them and solve them.
- Utilize caching techniques, optimize database queries, and minimize HTTP connections to improve the efficiency of your PHP code.
- After thoroughly testing your web application and making any necessary corrections, deploy it to a live server or hosting environment and test it once more to make sure everything isfunctioning as it should.
- b) CREATING REPOSITORY IN ELASTIC CON-TAINER REGISTRY
- Log into your AWS account and go to the ECR service to create an ECR repository. To start a new repository, click the "Create repository" button. Click the "Create repository" button after providing a name for your repository.
- Enter the ECR repository's login information on the screen that appears once the repository has been created. To access the ECR repository, copy the login command and run it in your terminal.

Create a Docker file in the project directory that details the image to use, the commands to execute, and any required dependencies to accomplish this.
