PaaS is a stage that is given to customers to create and convey programming. The customers can concentrate on the application advancement as opposed to stressing over equipment and framework. It likewise deals with the greater part of the working frameworks, servers and systems administration issues. Azure Backup and Azure Site Recovery share the same kind of Azure portal experience. They are different services and have different value propositions. Azure Backup is about the backup and restore of data on-premises. In the cloud they keeps your data safe and recoverable. Azure Site Recovery is for replication of virtual or physical machines. It keeps your workloads available in an outage. Azure backup has many applications. Native support for virtual machines, both Windows and Linux, files and folders on Windows OS machines either physical or virtual, popular Microsoft server workloads, windows 10 client machines.

The high level requirement for disaster recovery is to design a dashboard which should provide information about the VM's, Database, File Share which are configured for the Disaster Recovery and the methods of the DR. Disaster Recovery is a technology that minimizes IT services disruption and their recovery. It will check whether the last snapshot date and time equivalent to the current date and time is. Then High Availability configuration information will be displayed on the screen.

The flowchart of Azure dashboard is shown in Fig below




Fig. 1: The flowchart of Azure dashboard

Tenant ID is a unique ID which is given to particular organization.Azure Active Directory (Azure AD) uses OAuth 2.0 to authorize access to web applications and web APIs in your Azure AD tenant. It is used to perform authentication and authorization in most application types, including web applications and natively installed

applications. Registration of your application with your AD tenant has to be done.

Users will login to the application using the Email ID and password and authentication happens via active directory.
