1.Introduction

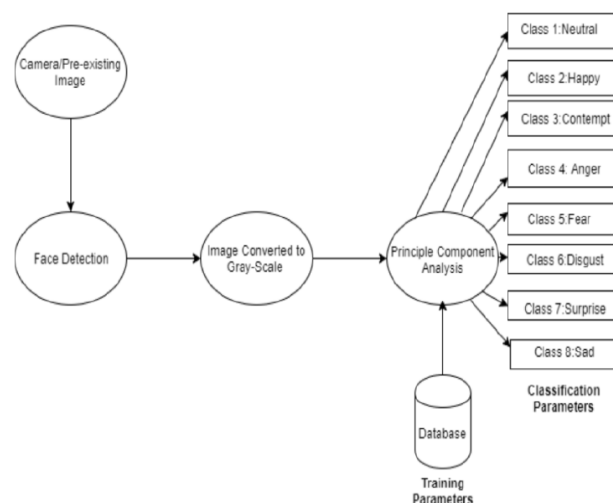

The authors also evaluated methods for collecting data sets and performed extensive studies on FER Plus and Affect Net. This paper proposes a method to obtain state-of-the-art results from various datasets including FER+, RAFDB, SFEW, and Affect Net.



Methodology

The data consists of a 48x48 pixel grayscale face image. These images were registered in 2013 with the face covering most of the center of the image and occupying the same position in each image. Kaggle ran a contest to classify this data set as one of the moods (0=angry, 1=hate), 2=fear, 3=joy, 4=sad, 5=surprise, 6=neutral). The fer2013 data set used in this project has two columns: "emotions" and "pixels". The "mood" column contains a number from 0 to 6 (inclusive) as described above for the emotions in the image. The second column has a row for each image. This string is a space-separated pixel value in string order. The data set only contains a "pixel" column and the task was to classify the sentiment column. The training sample consists of 28,709 examples. As a result of the study, Pierre-Luc Carrier and Aaron Courville made four of these data sets publicly available. Various implementations and comparisons have been made with models generated using different algorithms using different methods. This project demonstrates how this dataset can be further refined using

algorithms to focus more on important facial features and alignments. The percentage of accuracy predicted by the model gives you a better idea of what improvements can be made with multiple pre-processing iterations.

 - 5) The dataset is divided into a training set and a classification set. The training set is used to train emotion types by extracting information from a set of images, and the classification set is used to evaluate the performance of the classifier.
 - 6) For best results, images should have the same properties, i.e., size.
 - 7) Analyze the subject of each image, convert to grayscale, crop and save to catalogue.
 - 8) Finally, compile the training test data and classify the classification set. Repeat this process to increase efficiency.
 - 9) Then assign the ANN network and you will see a table with information about the layers and layer sizes, training model parameters.

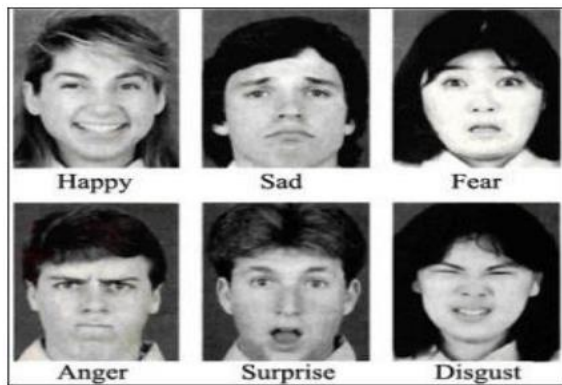


Fig.4 Output of a sample image [9]
