Deal Closure: When a match is made, Project Investopedia facilitates the investment process, ensuring both parties are satisfied.

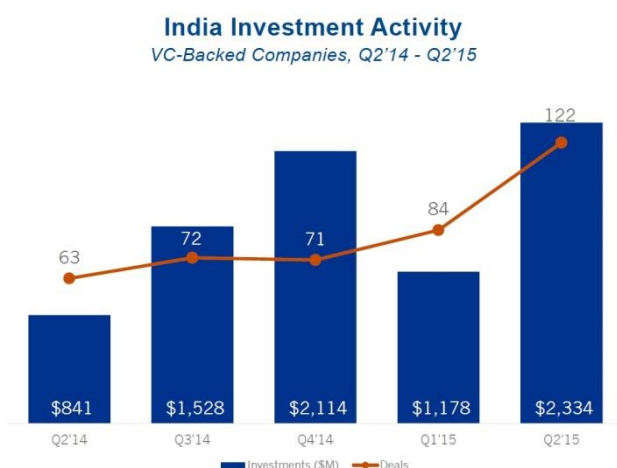
Benefits:
