The aids and appliances supplied under the Scheme must have due certification. The scheme also envisages conduct of corrective surgeries, wherever required, before providing an assistive device. Under the Scheme, grants-in-aid are released to various implementing agencies (Artificial Limbs Manufacturing Corporation of India (ALIMCO)/National Institutes/Composite Regional Centres/District Disability Rehabilitation Centres/ State Handicapped Development Corporations/ NGOs, etc.) for purchase and distribution of aids and assistive devices. 'ADIP Scheme' is a unique initiative of the Government of India to bring in real social changes on the ground. Under this scheme, 'Divyangjan' or physically disabled people are offered required aids and assistive devices to lead an honoured life. Launched by the Ministry of social Justice and Empowerment of the central government, the scheme assists the needy disabled persons in procuring durable, sophisticated and scientifically manufactured, modern, standard aids and appliances that can promote their physical, social and psychological rehabilitation by reducing the effects of disabilities and enhance their economic potential. Many people with disability are unable to afford the costs associated with traveling to health services, paying for medicine, and needed appliances. Computer education is also imparted along with craft and vocational training. 3- Rehabilitation Grant: Rehabilitation grant is offered to Differently Abled persons from the age of 18 to 45 years for self employment. During the year 2011, INR 18 lakh was granted against 180 Differently Abled persons. 4-

been made for the Differently Abled students studying in schools, colleges, Universities etc to promote the education among Differently Abled people.
