## **INTRODUCTION**

Men and women are not only two basic components in our society but are considered as two wheels of a chariot that depends on each other to constitute a population. Women in India from vedic period till date have changed with times. She was suppressed, worshipped, respected while at the same time she was subjected to violence. Hence it is necessary to analyse her status in the various ages to assess her present position in the society. <sup>1,2</sup>

## History of women in vedic period (1500 BC – 1000 BC)

The Indian culture tradition begins with vedic period (300 BC to 600 BC). During this period, women were given complete freedom, she was treated as Ardhangini in a family and received equal education on par with man, marriages were not imposed on her, after completion of education she had a power to select her life partner. A spinster had a right to inherit her father's property. Prabhus has rightly remarked that in vedic period, women had equal rights in social, economic, political and religious fields.

# Status of women during the epic period (1000 BC to 500 BC)

Epic age was regarded as golden age of women wherein she was well educated and accorded a honourable status in socio economical and political activities. She was depicted in two great epics as root of dharma, pleasure and prosperity when woman possessed unconditioned economic freedom. During Ramayana and Mahabharatha, women were accorded a respectable position. Hence they were called roots of Dharma, prosperity and enjoyment. Women were dignified with a respectable status, honoured, participated in all socio cultural activities on par with men. During Rig vedic period, all genders were offered the privilege of equal education and opportunities.

# Jainism and Buddhism period (600 BC to 200 BC)

During this period, the women were encouraged to lead a liberal and honourable life, she achieved excellence in painting, music and fine arts. However, women's economic status deterioted during this period as she was prohibited in political participation. During this era manu law stated that childhood of female must be subjected to her father, in youth to her husband and after death of her husband to her sons.

# Dharmasastra period

The conflicting social and religious thoughts converted the position of women to the sub ordinate, women were deprived vedic learning, gender inequality creped into society. During Dharmasastras, Sati was in practice, women were barred from practicing religious activities women status began to decline in 200 BC in Dharmasastra period with manusmitri. Many research studies have emphasized the role played by Indian societal structures in molding the women status which overtime had hindered their progress. Women's dignified role and position were portrayed in the ancient era has been categorized into four distinct periods –

Empowerment is a multi dimensional processes which helps a women to release their identity, resources, power and control, confidence, responsibilities to plan her lives and free themselves from customs, belief and practice imposed by society with progressing eras. <sup>1,-2</sup>

## What is a need for empowerment

Empowerment of women is a need as woman is the first teacher of the future citizen who can infuse good qualities into her children, for improving her socio economic and political strength in an environment where there is no gender bias, she can take her own decision makes her self confident.<sup>3</sup> Human develop report 1995 stresses that empowerment must be by people but not only for them. Women must participate in decision & process that shapes their lives, to exercise their choice which is not only valuable but also surest way for economic growth as such idea of engaging / performing multi tasking has become a mandatory / accepted social norm in her career advancement. <sup>3,4</sup>

#### Challenges / barriers to women empowerment

- 1. Discriminatory societal norms:- The biggest barrier is the mindset of society where woman is expected to go to work after performing her domestic works like cooking, taking good care of her family members including elders. Many women find it very hard to cope up with the situation without help / support from the family members. And there are many instances where they are criticized for neglecting the needs of the family instead of depending more on their career. She is asked to concentrate more on affairs of her husband's family than on her parents side thus is a great hindrance in woman empowerment.
- 2. Access to productive resources:- Another most difficult challenge is woman rights to land and other productive resources that are essential to improve her standard of living and ensure right to equality that prevent a women's access to use or control over immovable property and other important economic assets which are under the control of her husband, brother, son, etc. <sup>5, 6</sup>

3. Sexual harassment:- Sexual harassment is a type of harassment involving unwelcome behavior which can be verbal, physical or written which can affect people in different ways that makes some one feel upset, scared, offended or humiliated.<sup>7</sup> Previously in the name of traditions and customs women were denied rights and opportunities thus making them centric to family responsibilities and thereby derailing their careers. The sexual harassment can include sexual rumors (in person, by text or social media and jokes which are against the law.

The outcome of sexual harassment can have a negative psychological health and job related outcomes. The health and psychological related outcome includes anger, irritation, depression, sickness or even suicide. On the other side job related outcomes includes lower job satisfaction, absenteeism, career interruption, decreased commitment etc. Women in senior position are made vulnerable by that the fact that they are women. The coping strategies are be assertive, confronting, denial, reporting the incidence, advocacy seeking etc. More institutionalized combating efforts are also needed to prevent work place sexual harassment Some things that help to avoid the situation - Know the truth that it is not your fault tell the person to stop, share or report it to an adult / close friends / relatives get support from police or other trusted people.

- 4. Gender discrimination:- This persists globally in the work place, educational settings in relationship and organization on the whole in the system. The reason for this discrimination is unequal access to education. Legal rights to employment. (only 6 Nations have given legal rights to women) job segregation death of legal safe guards, lack of corporeal autonomy, inadequate health care, religious freedom and racism which has an impact on physical and mental health. Hence there is a need for gender equality for financial freedom and equal access to education. Gender equality is 5<sup>th</sup> goal among the 17 sustainable development goals adopted by United Nations is necessary for empowering women to eliminate all forms of violence's and harmful practices against women to ensure equal opportunities for leadership at all levels to undertake reforms to ensure universal access to health and women rights to economic resources financial services in accordance with laws. <sup>8.9.10</sup>
- **5.** Adult literacy program results in improvement of women equality as empowerment means moving from the weak position to execute a power to educate women, establishment of schools, colleges and universities by providing a package of concessions in form of free books, uniform, boarding and lodging, free cycles and so on can bring reduction in inequality.

**6.** Political empowerment is a must for all round development of the women but impartment of social education is needed before giving a concrete shape to their political empowerment and also to give due share to each and every section of the women.

Development of women and children in rural area program (DWCRA, 1993) aims to provide self employment, empowerment to women living in neighborhoods with similar socio economic background to act up any economic activity suited for their skills, trade on basis of their resources in agriculture and allied activities. - **3.** Women need confidence to fight against all the atrocities against her and also to eliminate the inferior complexity.
- 4. Women are not given an opportunity to study, though the government are making serious attempt to fight and root out the evils prevailing from time to time in under developed and developing countries. Hence a united stand is needed to voice her opinion from a common platform through social media, educate on the roots of violence, stop victim blaming, be supportive, be a mentor, organize training programs and workshops so on.
