1.Introduction

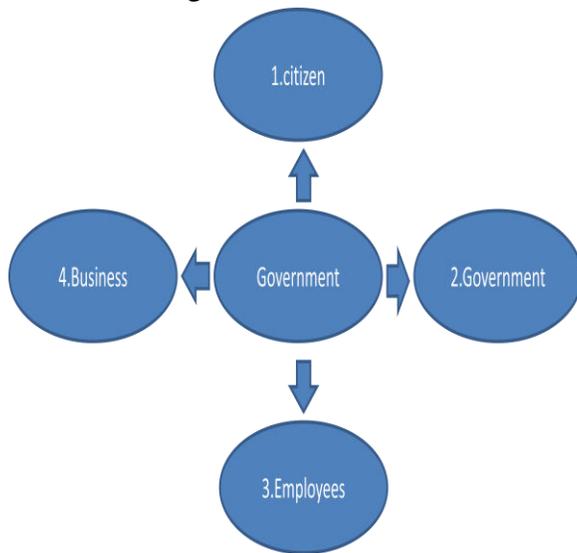
Electronic governance or e-governance is the procedure of processing information and communication technology (ICT) to provide variety of government services, transformation of information,

- Rise in GDP

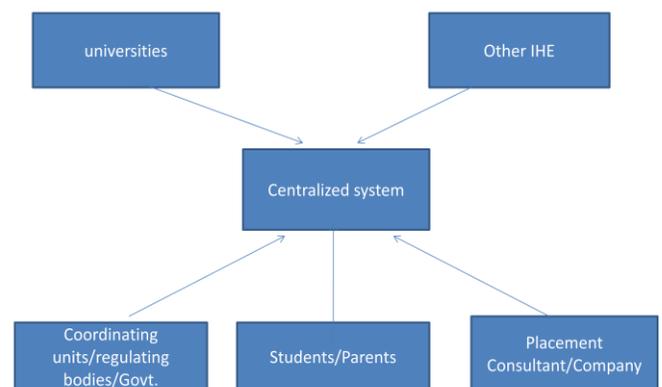
4. Use of e-governance in higher education
